Dear Ms. Bachman:

I write with respect to my client's interest in the Docket No. 512 telecommunications facility. The proposed Homeland Towers LLC ("Homeland") wireless facility at 60 Vale Road would allow Cellco Partnership d/b/a Verizon Wireless ("Cellco") to provide its customers with improved wireless service in Brookfield, Connecticut. That need, however, is not currently a priority in Cellco's build program budget. As such, Cellco will not intervene in the Docket No. 512 proceeding.

If Cellco was interested in sharing the proposed Homeland facility today, it would seek to install antennas at the highest available antenna locations on the tower (151 feet above ground level). The tower height that Cellco ultimately selects, however, will depend on a number of factors including, but not limited to, the state of network operations in the Brookfield area and the development of other surrounding sites in the future.
