RE: **DOCKET 488** – Homeland Towers, LLC and New Cingular Wireless PCS, LLC d/b/a AT&T application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a telecommunications facility located at one of two sites: Kent Tax Assessor ID #M10, Block 22, Lot 38 Bald Hill Road or 93 Richards Road, Kent, Connecticut.

During a public hearing of the Connecticut Siting Council (Council) held on September 3, 2020, the Council ruled on the following motion:

- 1. Applicants Motion to Strike the Testimony of Robert Todd Powell and Paul Elconin submitted by Intervenor Planned Development Alliance of Northwest CT and the Testimony of Marleen Donnenfeld submitted by Intervenor South Spectacle Lakeside Residents, dated August 31, 2020.**

The motion was denied.

Mr. Powell's Late-Filed Testimony, dated August 27, 2020 will be verified and subject to cross examination during the appearance of the Planned Development Alliance of Northwest CT, Inc. at a continued evidentiary hearing session.

Mr. Powell's pre-filed testimony, dated July 16, 2020; Mr. Elconin's pre-filed testimony, dated July 15, 2020; and Ms. Donnenfeld's pre-filed testimony, dated July 16, 2020 were verified and subject to cross examination at the August 11, 2020 continued evidentiary hearing session.

Continuation of Evidentiary Hearing

The Connecticut Siting Council (Council) shall continue the remote evidentiary hearing session for the above-referenced proceeding on **September 22, 2020** via Zoom conferencing, beginning at **2:00 p.m.** A copy of the Instructions for Access to the Continued Evidentiary Hearing is attached.

The hearing shall commence with the continued cross examination of the Grouped Intervenor Planned Development Alliance of Northwest CT, Inc., Spectacle Ridge Association, Inc. and South Spectacle Lakeside Residents by the Applicants and other parties, followed by the appearance of the Town for cross examination of Kent Conservation Commission Chair Connie Manes by the Council, Applicants and

other parties and intervenors, followed by the appearance of the Applicants for cross examination on the August 26, 2020 Late-Filed Exhibits by the Council and other parties and intervenors.

- All participants are requested to mute sound notifications on their computer, smartphone or tablet. Telephones are often equipped with a “do not disturb” feature for the dial-in option.
