**MOTION TO REOPEN RECORD FOR LIMITED PURPOSE AND TO MODIFY  
BRIEFING SCHEDULE**


NTE Connecticut, LLC (“NTE”), as the applicant, hereby moves to reopen the record and the evidentiary hearing in Docket No. 470 for the limited purpose of introducing evidence related to the results of Forward Capacity Auction (“FCA”) 11 conducted by ISO-New England on February 6, 2017 and NTE’s participation in that auction, as summarized in the attached Supplemental Testimony of Seth Shortlidge. There was considerable testimony during the proceedings in this docket regarding FCA 11 and its relevance to the issues being decided by the Council. Now that the auction has been completed, NTE believes the Council would benefit from having this additional information as it deliberates on the application.

NTE also requests that the Council modify the current briefing schedule, holding it in abeyance until the Council can rule on this motion. If the motion is granted, there will be additional evidence introduced into the record to which the parties may wish to refer in their briefs.

Therefore, NTE respectfully requests that the record and the evidentiary hearing in Docket No. 470 be reopened for the limited purpose of receiving evidence related to the results

of, and NTE's participation in, FCA 11 and that the current briefing schedule be held in abeyance until such time as the Council rules on this motion.


