




Street names in shaded areas are on map on other side.

Field Review Location: 208 Valley Road, New Canaan (Silver Hill Hospital)
July 13, 2010, 2:00 p.m.

Hearing Location: New Canaan Town Hall, 77 Main Street, New Canaan
July 13, 2010, 3:00 p.m.

Suggested Dinner Location: Gates Restaurant & Bar, 10 Forest Street (Across from Town Hall)

TO FIELD REVIEW – 208 Valley Road, New Canaan

To Site via Route 15 Southbound

Travel via Route 15 South to exit 38 (Route 123 - North)
Turn left onto Route 123 North
Follow Route 123 North (New Canaan Avenue, which becomes New Norwalk Road) – Travel approximately 1.7 miles
Turn right onto Silvermine Road (Route 106 - East) – Travel approximately 1.5 miles
Follow Silvermine Road to Valley Road, turn left onto Valley Road – Travel approximately 0.4 miles
Driveway to Silver Hill Hospital (Site) will be on the left

To Site via Route 15 Northbound

Travel via Route 15 North to exit 38 (Route 123 - North)
Turn right onto Route 123 North
Follow Route 123 North (New Canaan Avenue, which becomes New Norwalk Road) - Travel approximately 1.7 miles
Turn right onto Silvermine Road (Route 106 - East) – Travel approximately 1.5 miles
Follow Silvermine Road to Valley Road, Turn left onto Valley Road – Travel approximately 0.4 miles
Driveway to Silver Hill Hospital (Site) will be on the left

TO HEARING LOCATION – 77 Main Street

From 208 Valley Road to New Canaan Town Hall

Follow Valley Road, heading south, to Silvermine Road (Route 106) – Travel approximately 0.4 miles
Turn right onto Silvermine Road (Route 106)
Route 106 becomes East Avenue – Travel approximately 2 miles total on Route 106
Turn right onto Main Street
Drive past Town Hall (the hearing location), which is on the left
Take next right onto Locust Avenue
Take first left into the Locust Avenue Lot. This is where parking is available. Do not park in the lots behind Town Hall as those are pay lots.

To Hearing Location via Route 15 Southbound

Travel via Route 15 South to exit 38 (Route 123)

Turn left on New Canaan Avenue (Route 123), which becomes New Norwalk Road – Travel approximately 1.7 miles

Turn left on East Avenue – Travel approximately 0.5 miles

Turn right onto Main Street

Drive past Town Hall (the hearing location), which is on the left

Take next right onto Locust Avenue

Take first left into the Locust Avenue Lot. This is where parking is available. Do not park in the lots behind Town Hall as those are pay lots.

To Hearing Location From Route 15 Northbound

Take Route 15 North to exit 37 (For Route 124)

Turn left onto Route 124 (South Avenue)

Follow Route 124 north toward the center of New Canaan

Route 124 will become Main Street

Drive past Town Hall (the hearing location), which is on the left


Take next right onto Locust Avenue

Take first left into the Locust Avenue Lot. This is where parking is available. Do not park in the lots behind Town Hall as those are pay lots.
