**LEGAL NOTICE**

Notice is hereby given, pursuant to Section 16-50(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on or about February 11, 2011, by Cellico Partnership d/b/a Verizon Wireless ("Cellico" or the "Applicant"). The Application proposes the installation of a wireless telecommunication facility on an approximately 10.8 acre parcel south of Day Hill Road in Bloomfield, Connecticut. At this site, Cellico proposes to construct a 110-foot monopole telecommunication tower. Access to the site will extend from Day Hill Road over a new gravel driveway a distance of approximately 1,250 feet to the cell site. Cellico will also install a 12' x 24' shelter near the base of the tower to house its radio equipment and a propane-fueled back-up generator. The tower, equipment shelter and 1,000 gallon propane tank will all be installed inside a 47' x 76' fenced compound. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes § 16-50a et seq.

On the day of the Siting Council public hearing on this proposal, Cellico will fly a balloon at the height of the proposed tower described above. Interested parties and residents of the Towns of Bloomfield and Windsor are invited to review the Application on or after February 14, 2011, during normal business hours at any of the following offices:
