Pursuant to Condition No. 6 of the Certificate issued April 2, 2018, the Council hereby grants your request for an extension of construction time in this matter until September 30, 2020, to complete the construction of this facility.

Pursuant to Condition Nos. 6 & 7 of the Certificate, any request for an extension to fully construct this telecommunications facility with at least one fully operational wireless telecommunications carrier shall be filed with the Council not later than 60 days prior to the expiration of this Certificate and shall be served on all parties and intervenors, as listed on the current service list.

This extension is granted with the understanding that the Council will be notified should the Certificate Holder decide not to proceed with construction.

This letter is respectfully submitted on behalf of Eco-Site, Inc. (“Eco-Site”), the Certificate Holder in Docket No. 478.

On November 1, 2019, the Council granted an extension of construction time until June 30, 2020 pursuant to Condition No. 6 of the Certificate dated March 29, 2018. At this time, the tower facility is constructed and at least one carrier, AT&T, has installed its facility on the tower. Eco-Site recently executed the utility easement required for the facility and respectfully requests a three month extension of time to September 30, 2020 for the installation of the utilities and for the wireless facilities to become operational. This request is being timely made in accordance with Conditions 6 and 7 of the Council’s Docket No. 478 Decision & Order.

If the facility becomes operational prior to September 30, 2020, Eco-Site will notify the Council.
