SIGN POSTING AFFIDAVIT
CONNECTICUT SITING COUNCIL DOCKET NO. 484

I, Michael Libertine, being duly sworn, deposes and states that:

1. I am over eighteen years of age and I understand the obligations of a statement under oath.
2. I am the Director of Siting and Permitting for All-Points Technology Corp., P.C. (“APT”).
3. APT has been working closely with the Docket No. 484 applicant, Cellco Partnership d/b/a Verizon Wireless in its application to establish a wireless telecommunications facility at 72 Ragged Hill Road, Pomfret, Connecticut (the “Site”).
4. Under my direction and supervision, APT was responsible for the posting of Public Notice Signs at the Site.
