RE: **DOCKET F-2012/2013** - Connecticut Siting Council Review of the Ten-Year Forecast of Connecticut Electric Loads and Resources.

SCHEDULE

I. Introduction

Pursuant to General Statutes (CGS) § 16-50r, every person engaged in electric transmission services, as defined in section 16-1, electric generation services, as defined in said section, or electric distribution services, as defined in said section generating electric power in the state utilizing a generating facility with a capacity greater than one megawatt, shall annually file a report on a forecast of loads and resources not later than March 1. The report shall cover the ten-year forecast period beginning with the year of the report.

II. Public Hearing and Council Report

Pursuant to the same section, the Connecticut Siting Council (Council) may issue a report on the forecast review. This schedule allows for a final biennial report (2012-2013) to be released in 2013.

Pursuant to CGS 16-50r, the Council shall hold a public hearing annually and at least one session of the hearing shall be held no earlier than 6:30 p.m. Accordingly, the Council will hold its first evidentiary hearing session and public comment hearing session in New Britain on June 12, 2012.
