

**REPORT OF FORECAST OF LOADS AND RESOURCES
OF WALLINGFORD ENERGY LLC**

Pursuant to the provisions of Section 16-50r of the Connecticut General Statutes, Wallingford Energy LLC (formerly, PPL Wallingford Energy, LLC) hereby submits this report of its ten-year forecast of loads and resources.

(1) A Tabulation of Estimated Peak Load, Resources and Margins for Each Year

Wallingford Energy is Wallingford Energy LLC's sole power generating asset in the State of Connecticut. Wallingford Energy has the capacity to generate 225 net megawatts (MW) of electricity.

Wallingford Energy, as a wholesale power producer, does not have a franchised territory within which it would estimate peak load requirements or margins for the period 2015 through 2025, and therefore, no such estimates are offered.

(2) Data on Energy Use and Peak Loads for the Five Preceding Calendar Years

Wallingford Energy, located at 115 John Street, Wallingford, is a 225 MW simple cycle generating facility that utilizes pipeline quality natural gas.


