

In order for the incomplete requests to be satisfied and the exempt modification request to be processed and acknowledged the following conditions need to be met as stated in the letters issued by the Council (see attached):

1. Provide proof of notice to the underlying property owner listed as **Chapin and Bangs Company** in the property card provided with the EM request. This notice should be in the form of mailing receipts or delivery acknowledgements issued by the parcel carrier.
2. Provide a valid filing fee check in the amount of \$625 since the original check provided did not clear.

Once these requests have been satisfied the Council will issue an acknowledgement notice and the exempt modification request will be processed
