RE: **EM-T-MOBILE-043-180731** – T-Mobile notice of intent to modify an existing telecommunications facility located at 100 Sunset Ridge Road, East Hartford, Connecticut.

Dear Ms. Sabo:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on July 31, 2018.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified a deficiency in the structural analysis report provided with the above filing. The above-referenced exempt modification filing includes a structural analysis report dated June 25, 2018. Previous to that date, the Council acknowledged a Sprint exempt modification on July 9, 2018 with a structural report dated April 20, 2018.

The June 25, 2018 structural analysis report provided with your filing, does not account for the approved Sprint equipment. Please refer to Sprints June 20, 2018 request for exempt modification for this facility (EM-Sprint-043-180622) available on the Council's website at the following link:

Therefore, the exempt modification request is incomplete at this time. The Council recommends that Northeast Site Solutions provide an updated structural analysis report accounting for Sprint's approved equipment, as well as any required mount modifications included in the mount analysis report on or before September 11, 2018. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to September 11, 2018.

This notice of incompleteness shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
