To Whom It May Concern:

Infinigy has reviewed construction photos and general contractor redlined as-built drawings, provided by SBA Communication Corp. of the site at the aforementioned location. Construction appears to have been completed in general conformance with the Construction Drawings Rev. 0, dated March 23, 2018 by Infinigy Engineering PLLC and reviewed by Bluewave Communications on March 20, 2019, with the following minor deviations from the original design:

- Regarding sheet A-3, three (3) additional stiff-arm members have been installed per the structural recommendations, connecting the proposed horizontal pipes with the adjacent sector proposed horizontal pipes. This is not shown on detail 2/A-3.
- Regarding sheet A-3, the existing horizontal pipe has been field cut to 6'-6" length per the structural recommendations, therefore there are only (2) mounting pipes per sector and not four (4) as shown in detail 2/A-3.

The installation appears to have been completed in general conformance with the structural recommendations provided in the Antenna Mount Structural Analysis Report by GeoStructural, LLC, dated March 15, 2018 and in accordance with all state and local building codes.

**RE: EM-SPRINT-058-180713** - Sprint notice of intent to modify an existing telecommunications facility located at 131 Bishop Crossing Road, Griswold, Connecticut.

Dear Ms. Pelletier:

The Connecticut Siting Council (Council) hereby acknowledges your notice to modify this existing telecommunications facility, pursuant to Section 16-50j-73 of the Regulations of Connecticut State Agencies with the following conditions:

1. Prior to Sprint's antenna installation, the antenna mount and platform modifications shall be installed in accordance with the Antenna Mount Structural Analysis Report prepared by Geostructural dated March 15, 2018 and stamped and signed by Gregory Durgin;
2. Within 45 days following completion of equipment installations, Sprint shall provide documentation certified by a professional engineer that its installation complied with the recommendations of the Antenna Mount Structural Analysis Report;
3. Any deviation from the proposed modification as specified in this notice and supporting materials with the Council shall render this acknowledgement invalid;
4. Any material changes to this modification as proposed shall require the filing of a new notice with the Council;
5. Within 45 days after completion of construction, the Council shall be notified in writing that construction has been completed;
6. Any nonfunctioning antenna and associated antenna mounting equipment on this facility owned and operated by Sprint shall be removed within 60 days of the date the antenna ceased to function;
7. The validity of this action shall expire one year from the date of this letter; and
8. The applicant may file a request for an extension of time beyond the one year deadline provided that such request is submitted to the Council not less than 60 days prior to the expiration.


The proposed modifications including the placement of all necessary equipment and shelters within the tower compound are to be implemented as specified here and in your notice dated July 12, 2018. The modifications are in compliance with the exception criteria in Section 16-50j-72 (b) of the Regulations of Connecticut State Agencies as changes to an existing facility site that would not increase tower height, extend the boundaries of the tower site by any dimension, increase noise levels at the tower site boundary by six decibels or more, and increase the total radio frequencies electromagnetic radiation power density measured at the tower site boundary to or above the standards adopted by the Federal Communications Commission pursuant to Section 704 of the Telecommunications Act of 1996 and by the state Department of Energy and



Environmental Protection pursuant to Connecticut General Statutes § 22a-162. This facility has also been carefully modeled to ensure that radio frequency emissions are conservatively below state and federal standards applicable to the frequencies now used on this tower.

This decision is under the exclusive jurisdiction of the Council. Please be advised that the validity of this action shall expire one year from the date of this letter. Any additional change to this facility will require explicit notice to this agency pursuant to Regulations of Connecticut State Agencies Section 16-50j-73. Such notice shall include all relevant information regarding the proposed change with cumulative worst-case modeling of radio frequency exposure at the closest point of uncontrolled access to the tower base, consistent with Federal Communications Commission, Office of Engineering and Technology, Bulletin 65. Thank you for your attention and cooperation.
