Dear Mr. Roberts:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on April 3, 2018.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified a deficiency in the filing. The construction drawing Sheet C02 prepared by Dewberry Engineers Inc., last revised on March 9, 2018, depicts a proposed platform reinforcement kit as required by an Appurtenance Mount Modification Report prepared by B+T dated March 1, 2018. The proposed platform reinforcement kit was not included the Structural Analysis Report prepared by Paul J. Ford & Company dated January 25, 2018.

Therefore, the exempt modification request is incomplete at this time. The Council recommends that QC Development provide an updated Structural Analysis Report that includes all existing and proposed equipment on the tower as shown in the construction drawings of March 9, 2018 on or before May 3, 2018. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to May 3, 2018.

This notice of incompleteness shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
