RE: **Petition 1397** – Constitution Solar, LLC petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a 20-megawatt AC solar photovoltaic electric generating facility on approximately 149 acres comprised of four separate parcels located off of Cornell Road in Plainfield, Connecticut and associated electrical interconnection – **Development and Management Plan Conditional Approval**

Dear Ms. Bachman:

I am writing on behalf of the Petitioner, Constitution Solar, LLC, ("Constitution") to request the Connecticut Siting Council's ("Council") approval of certain revisions to Constitution's approved Development and Management Plan ("D&M Plan" as outlined below).

On May 10, 2021, the Connecticut Department of Energy and Environmental Protection ("DEEP") notified Constitution that its Connecticut Construction General Permit ("General Permit") application was insufficient ("Notification"). Since that time, Constitution has been diligently conducting the actions necessary to comply with recommendations outlined in the Notification. Specifically, the Notification required Constitution to conduct additional stormwater testing in numerous locations on the project site. Conducting testing at one of these locations requires Constitution to take actions subject to Council review and approval.

One of the testing sites ("Test Site") consists of three test pits located in one basin, identified in the attached map as Basin 3B. During the field reconnaissance conducted in advance of the additional stormwater testing, Constitution confirmed that Basin 3B intersects the unusual stone wall that was previously identified on the project site and the construction of the stormwater

basin will require removal of a portion of the stone wall.² This stone wall was identified during project development, and in consultation with the State Historic Preservation Office ("SHPO") it was determined that Constitution would avoid disturbing the wall during site construction.³ Constitution has been unable to identify an alternative location for Basin 3B that would avoid disturbing the stone wall. Accordingly, Constitution has consulted further with SHPO on a proposed plan for the preservation of the stone wall, which SHPO has approved.⁴ This plan consists of the careful dismantling and removal of the stone wall from its current location and reconstructing the stone wall to its approximate current appearance and alignment in a nearby location within the Project site. Constitution seeks Council approval of the proposed preservation of the stone wall in accordance with this plan, including the proposed dismantling and removal of a portion of the stone wall at this time to access and conduct the necessary testing at the Test Site in Basin 3B.

In addition, the Test Site at Basin 3B is in a location that requires the clearing of a minimal number of trees to provide access. As outlined in the November 11, 2020 Revised Final Determination of DEEP's Natural Diversity Data Base ("NDDB"), no cutting of trees can occur on site between May 15th and October 31st to protect state listed bat species. Constitution has coordinated with NDDB and received its approval on its proposed plan to conduct limited tree clearing to access the Test Site at Basin 3B. Constitution seeks Council approval of its proposed, limited tree clearing work to conduct the necessary testing at the Test Site at Basin 3B.

Attached to this letter are maps identifying the Test Site at Basin 3B, the location of the stone wall in relation to Basin 3B and the Test Site, and the limited amount of tree clearing necessary to access the Test Site.

Accordingly, Constitution seeks Council approval of its proposed approaches to access the Test Site at Basin 3B and to preserve the unusual stone wall in accordance with the plan developed in consultation with, and approved by, SHPO. 



Hi Dawn,

As a follow-up to our discussion earlier today regarding tree clearing proposed at the Constitution Solar site, please find attached a sketch map showing the area in the northeast portion of the site where soil sampling work is required in support of the stormwater basin design. These surveys were requested by DEEP to facilitate their review and approval of the stormwater permit for the project.

Limited tree clearing is needed to facilitate excavator access for soil sampling and perc tests within the proposed basin area. Based on a field review of the woody area needing access, we have estimated a maximum of approximately 30 trees would be required for removal within the outline shown on the attached sketch. To the extent practicable, tree clearing will be minimized and located within the least impactful route. No trees having a DBH greater than 12-inches or dead trees/snags will be removed. Selective clearing will focus on removal of trees having a DBH of 3-inches or less, and where that is not possible, conifer trees will be chosen for removal (vs. hardwood species). To the best of our ability we will cut hardwood trees between 3-12 inches only if necessary for access.

The attached sketch identifies a small segment of an existing stonewall to be removed, which is located within the basin area to be sampled. Constitution Solar, LLC has received approval from the SHPO to move this segment of the wall to facilitate access to the basin area, and the Project will coordinate with SHPO regarding methods for removal/replacement.

Our survey plan is to finish this site work this week, on Thursday. We respectfully request your approval of the limited tree clearing proposed, which is necessary to secure the stormwater permit and construction of the project. If would like to discuss this work in more detail, we can set up a phone call tomorrow with you and our environmental team.

If you would like to discuss this request further, we area available anytime before 11:30am tomorrow (Wed) if this works with your schedule. Let me know and I can set up a Teams meeting.

Ms Labadia,

As we discussed on the phone yesterday, Constitution Solar, LLC has encountered an issue during construction. They previously agreed to the protection in place of a non-typical stone wall in the southerastern portion of the project area. It has recently been discovered that the mapped location of the wall was in error and that it actually falls within a location for a proposed stormwater basin. As we discussed, Constitution Solar, LLC has agreed to move and reset the wall in a nearby location where it will not intersect with any elements of the solar project. Constitution Solar, LLC will label each large vertical stone within the wall, remove them, and stockpile on site in a safe location. They will also remove the intervening rubble stone wall segments between the vertical wall elements and stockpile them by segment. The wall will then be reconstructed as closely as possible to the original configuration. Constitution Solar, LLC is requesting your concurrence with this plan so that they may pass it along to the Connecticut Siting Council in support of their ongoing effort. If it is easier for you, an email repsonse will suffice. As always, thank you for you time and consideration.
