On behalf of the petitioner, Constitution Solar, LLC (the "Petitioner"), enclosed please find correspondence from the Connecticut State Historic Preservation Office ("SHPO") dated March 31, 2020 related to the Constitution Solar Project (the "Project").

On April 23, 2020, the Council granted the Petitioner's Motion for Protective Order related to the Phase IB/Phase II Cultural Resources Report prepared by Heritage Consultants, LLC on the basis it contains confidential information related to specific locations of cultural resources identified at the Project Site, pursuant to Connecticut General Statutes §1-210(b). The SHPO correspondence has been redacted to protect the confidential information in the Phase IB/Phase II Cultural Resources Report, namely the specific locations of cultural resources identified at the Project Site. An unredacted copy of the SHPO correspondence has been separately provided to the Council.

The Petitioner asks that the Council accept the SHPO correspondence as state agency written comments.

In addition, as a result of discussions with SHPO, the Petitioner has revised a buffer around a unique stone wall in Locus 4-1. The Petitioner has reflected this minor modification to the Project Layout in the enclosed Figure 1 -Stone Wall Buffer.

The State Historic Preservation Office (SHPO) has reviewed the archeological survey report prepared by Heritage Consultants, LLC (Heritage), dated January 2020. The proposed activities are under the jurisdiction of the Connecticut Siting Council and are subject to review by this office pursuant to the Connecticut Environmental Policy Act (CEPA). The proposed facility includes the installation of an 80 acre solar photovoltaic (PV) electric generating facility located within an approximately 149 acre study area, bounded by Black Hill Road and private residences to the south, to the east by Cornell Road, and to the north and west by the Quinebaug River. The facility will be interconnected by a right of way (ROW) leading to Black Hill Road. The submitted report is well-written, comprehensive, and meets the standards set forth in the *Environmental Review Primer for Connecticut's Archaeological Resources*.

In a letter dated March 26, 2018, the result of a Phase IA cultural resource survey, this office recommended that a Phase IB professional cultural resources assessment and reconnaissance survey that includes subsurface testing techniques be completed prior to construction in those areas identified to have moderate to high archaeological sensitivity.


proposed Constitution Solar Project would constitute <u>no adverse effect</u> to this important archaeological site <u>conditional</u> upon the professional data recovery utilizing a scope of work approved by this office prior to the initiation of any additional work.

Lastly, a single above-ground resource, an unusual stone wall exhibiting vertical stone segments used to hold horizontal logs to add height to the wall, was identified along the southeastern boundary of Area 4. This office concurs that the wall should be avoided during construction, and recommends that a 10 foot buffer be implemented, that tree clearing within the buffer occur only by hand, with no grubbing of stumps, and that the entirety of the wall be clearly marked on project maps and in the field so that construction crews can minimize harm to the wall.

SHPO appreciates the cooperation of all interested parties in the professional management of Connecticut's cultural resources. We look forward to additional consultation once the scope of data recovery is developed. These comments are provided in accordance with the Connecticut Environmental Policy Act.
