During a public meeting of the Connecticut Siting Council (Council) held on February 11, 2021, the Council voted to grant LSE Pictor, LLC's January 15, 2021 Motion to Reopen the Council's September 28, 2020 denial without prejudice of a declaratory ruling for the construction, maintenance and operation of a declaratory ruling for the construction, maintenance and operation of a 1.99-MW solar photovoltaic electric generating facility in Winchester based on changed conditions, pursuant to Connecticut General Statutes §4-181a(b).
