RE: **PETITION NO. 1405** – The Connecticut Light and Power Company d/b/a Eversource Energy declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed Horton Cove Circuit Separation Project consisting of a partial rebuild and separation of approximately 1 mile of its existing No. 100 69-kilovolt (kV) and Nos. 1410, 1280, and 1355 115-kV electric transmission line structures within existing Eversource electric transmission line right-of-way between a location east of Depot Road to a point east of Point Breeze Road, Montville, Connecticut, and related electric transmission line structure improvements.

The Connecticut Siting Council (Council) is in receipt of the email correspondence dated May 7, 2021, regarding temporary changes to work hours for the above-referenced declaratory ruling that was issued by the Council on July 20, 2020.

Pursuant to Condition No. 1 of the Council's Declaratory Ruling, your request to perform work from 7:00 p.m. to 8:00 pm on Friday May 7, 2021 to install safety equipment on the 1080 and 1280 lines crossing Horton Cove is hereby approved. The extended work hour is necessary to secure the existing conductor.
