Based on the nature of this petition for a declaratory ruling and requests received, the Council voted to hold a public hearing, although it is not required by law. The Council invites municipal participation at the remote public hearing. Municipal officials may request Party or Intervenor Status to actively participate in the evidentiary portion of the public hearing, present oral statements to the Council during the public comment session of the public hearing or submit written statements to the Council at any time before, during or within 30 days after the close of the evidentiary record.
