Good morning, Mr. O'Sullivan.

Thank you for your submission. We will add your attachment and the videos to your exhibit list if your request for intervenor status is granted at the hearing. However, please be advised that we will be unable to play the videos during the appearance of your case. Members, staff, parties, intervenors and the public may view them from a link on our website.

If your intervenor request is granted, you would most likely present your case, including, but not limited to, verification of pre-filed testimony, exhibits and cross examination of witnesses, at a continued evidentiary hearing session.
