In response to your request of December 4, 2020, during a hearing held on December 15, 2020, the Connecticut Siting Council (Council) granted you intervenor status in Petition No. 1425.

Parties and intervenors are required to serve all other parties and intervenors a copy of any material submitted in this petition, unless service is waived.
