Pursuant to the provisions of §16-50j-40(a) of the Regulations of Connecticut State Agencies, this letter serves as notice that SR Litchfield, LLC intends to file a Petition for Declaratory Ruling ("Petition") with the Connecticut Siting Council ("Council") on or about February 5, 2021, seeking approval of the construction, operation, and maintenance of a 19.8 megawatt ("MW")(ac) solar generating facility, including all associated equipment, related site improvements, and interconnection (the "Project").

The Project would be located on portions of six (6) separate parcels in the northern portion of the Towns of Litchfield and the southwest portion of the City of Torrington, Connecticut, totaling approximately 212 acres. Each of the parcels are owned by the Silicon Ranch Corporation. The Project would consist of the installation of ground-mounted photovoltaic panels, centralized inverters and transformers, electrical lines, an electric transformer, a station controller, a perimeter fence, and interior access roads. For additional detail regarding the location of the Property and the layout of site improvements, please see the attached Project Plan.
