Pursuant to Connecticut General Statutes (“C.G.S.”) Section 16-50n and Regulations of Connecticut State Agencies (“R.C.S.A.”) Section 16-50j-15, Cellco Partnership d/b/a Verizon Wireless (“Cellco”) hereby requests permission of the Siting Council (“Council”) to participate, as an intervenor, in the Petition No. 1547 proceeding.

Cellco is a wireless service provider, licensed to do business throughout the State of Connecticut. As described in Petition No. 1547, the proposed SBA Communications Corporation telecommunications facility at the Avon landfill property would fit neatly into Cellco’s network design and provide much needed service in western portions of the Town of Avon and eastern portions of the Town of Burlington, Connecticut.
