Dear Ms. Bachman:

The Town of Avon is currently planning a replacement of its existing public safety radio communications system. The proposed solution will improve communications for the Town's First Responders and requires a transmitting site located on the tower referenced in this docket.

Avon's current radio system experiences coverage gaps in most of the Avon Public School buildings. The current system's deficiencies pose a danger to the First Responders and therefore Avon Public Schools student body, faculty and staff should an emergency occur.

While this tower location does not directly provide RF coverage to our school buildings, this site is part of the larger replacement project which will improve communications for our First Responders in and around our schools. I am therefore in full support of the petition to extend the height of the existing tower to allow the proposed replacement of the public safety radio system to proceed and thereby improve public safety communications in our schools.
