EMF Best Management Practices

Dear Judge Caruso,

This proceeding was initiated in January, 2006, after the Council received a detailed report and recommendations from its consultant, Gradient Corp., with respect to the revision of the Council's EMF Best Management Practices ("BMP"). Thereafter, the Council published multiple drafts for comment, and conducted several days of public hearings, continuing into 2007. Then, on February of 2007, The Connecticut Light and Power Company ("CL&P") and The United Illuminating Company ("UI") (collectively, "The Companies"), together with The Connecticut Department of Health, submitted a joint proposal for the revised BMP. Additional hearings and rounds of comments ensued. More recently, in May of 2007, the Council solicited public comment on two alternate drafts of the revised BMP, one of which was based on the joint proposal of the Companies and CTDPH. Comments on these drafts were submitted in June, 2007. These drafts and comments were then referred to a subcommittee of the Council for its review and recommendation.

As far as I know, there has been no indication as to when the subcommittee intends to report to the Council, or when the Council will adopt the new BMP.


CL&P is in the process of identifying routes for, and designing, several transmission projects. Naturally, it intends to apply EMF Best Management Practices in this work. However, CL&P is hindered in doing so by the lack of guidance from the
