Most Popular links on the homepage are manually added to control what is being added. It may be possible to create an exception list instead and make dynamic. This would need further research.

The Lift/Shift strategy being developed by DAS/BEST and CI is a priority right now. The teams are working on a bulk migration strategy to speed up timelines and look to group agencies together for migrations and trainings.
