## **Title: Research Efforts**

Our Research Efforts include:

 Agency engagement to index the existing programs and partner in our resident outreach efforts.

We have had agency discussions with the following organizations:

DECD, Office of Early Childhood, Secretary of the State, Commission on Human Rights and Opportunities, Connecticut State Colleges and Universities, Connecticut Technical High School System, State Library, Aging and Disability Services, Department of Developmental Services, Corrections, Education, Housing, Labor, Public Health, Social Services, Veterans Affairs.

- Partner Survey: Used to develop a "digital equity asset map" of existing support programs statewide.
- Resident Survey: We have received more than 5,000+ responses addressing barriers to access, devices, and support.
- We have also hosted Focus Groups: Where we conducted small-group discussions with members of covered populations to understand barriers and capture suggestions for Five-Year Digital Equity Plan

#### Slide 7:

## **Title: Barriers**

Though our efforts to date we have identified the following Barriers:

While some of the barriers and technology preferences vary across covered populations. Others appear universal to CT residents regardless of covered population status.

#### **Universal Barriers:**

- 1. Privacy concerns "get in the way" of using the internet for many Connecticut residents.
- 2. Some CT residents require assistance to perform basic tasks that may affect access to services, such as:
  - Making an online account
  - Making a video call; or
  - Creating documents or spreadsheets

#### Slide 8:

## Title: General Barriers seen among covered populations

Among those individuals that fall into a covered population.

## In terms of:

- Broadband: Less likely to have a broadband connection, or any internet connection at all.
- Regarding Devices: Less likely to own a computer, and more likely not to have any device that connects to the internet.
- In the context of Competencies: Likely to report lower levels of confidence in their digital literacy and digital security skills.
- Support: Likely to face cost or location barriers to obtaining support when needed
- When it concerns services: Likely to have specific needs when accessing public services (e.g., mobile-friendly, or otherwise accessible websites)
