Energy Saving Retrofits Contract for Existing Buildings

Contract 16PSX0182 – Energy Saving Retrofits for Existing Buildings has been awarded and is now available for use by all state agencies, municipalities, boards of education, political subdivisions and not-for-profit organizations in Connecticut. The contract features 15 vendors that collectively offer a wide range of goods and services designed to reduce energy use, offer “green” energy alternatives and reduce all costs associated with energy consumption.

All forms of energy and utility processes are covered. Client agencies can make simple purchases of retrofit devices that optimize energy system operation, or they can seek proposals from contract vendors for major energy management projects such as a full building re-commissioning. Also available are energy consulting, monitoring and reporting services. Many of the contractors offer performance-based payment options that include no up-front expenditures with reimbursement occurring in the form of shared energy-cost savings.

Client agencies wishing to take advantage of the services offered on this contract should contact the Department of Energy and Environmental Protection as well as their energy service providers to learn of any funding or cash incentives that might be available to parties that engage in energy reduction initiatives.

Take 2 - Electronics Recycling for State Agencies

Did you know that the State of Connecticut has a contracted vendor to responsibly recycle used electronics generated by State Agencies? Take 2 is a Certified Woman Owned Small Business Enterprise, centrally located in Waterbury, CT and is the only Connecticut based CT DEEP authorized Covered Electronics Recycler and is a CT DEEP Permitted Electronics Recycler.

Under the contract, Take 2 recycles all state generated computers, printers, monitors, laptops, network equipment, audio visual equipment, televisions, phone systems, peripherals and other IT and office related equipment. Take 2 is authorized, under the contract, to provide on-site data destruction for all data containing devices. Take 2 also provides complete logistics support, including labor to pack materials, packaging supplies, and transportation via their own fleet of trucks and drivers.

Scheduling Service: Take 2 has developed a [Service Order Form](#) that allows State agencies to request a pick up through an on-line form. In addition to this form, agencies can call Take 2 to schedule a pick up.

Mobile Hard Drive Shredding: Take 2 is authorized, through the contract, to shred hard drives, thumb drives, and removable media at agency locations throughout the State. Each device is scanned to capture the serial number, prior to shredding. When the shredding is complete, agencies receive a detailed report, including serial numbers and a signed Certificate of Data Destruction.

Drop-off: Take 2 offers agencies the ability to drop off electronics for recycling, in addition to scheduling a pick up at their location. This allows agencies to reduce logistics costs on small shipments of electronics for recycling. Take 2 waives the transportation fee to any agency requesting a pickup of 100 items or more. Have you seen an electronics recycling operation in action? Come by with your electronics and get a tour of your vendor's operations and meet their team.

Educational Events: Any agency wanting to hold a free residential electronics recycling event for their employees can do so through Take 2. It is free to the organization hosting the event and a great service to the employees.
