What's in a Title? CT State Agencies Need to Know

More money is what's in a title when it comes to surplus state vehicles.

For years, due to various factors, state owned vehicles did not require a title to the vehicle, only a Certificate of Origin. However, when it came to selling that vehicle at auction, there were administrative issues.

“Working with DMV staff we are eliminating this problem by getting titles to all state vehicles right when they are purchased,” said DAS Supervisor of State Surplus Veronica Coty.

What's in a title? “When we surplus these state vehicles at auction, a clean title to a vehicle will generate more money than a vehicle with no title or only a Certificate or Origin,” said Coty.

“Our online auction website now reaches a greater number of customers around the country,” she added. “Before, we were mostly reaching customers in Connecticut and New England. Now that we are online, we need to have the title and all paperwork in proper order to make the sale quicker and easier for a larger number of customers. If everything is in order, we can generate a better auction price for the state.”

“Most importantly we need to let state agencies know that when they purchase a state vehicle they need to contact our office to begin the title process,” said Coty. “We are working to make this a more effortless process but for now it involves DAS, the agency and DMV.”

With that being said, if your agency purchases any new state vehicles, contact DAS' Veronica.Coty@ct.gov to begin the vehicle title process right from the beginning. It is important that we title any vehicles BEFORE they are registered. Once a vehicle is registered, creating a title negates the registration, which causes a lot of problems and a lot more work for DMV staff, so let's get them titled right away!

Another phase of the project is to get current state vehicles already on the road titled so when they do come to auction in the future, the process is much smoother. DAS Surplus Staff has already completed the project with DAS Fleet and are currently working with UConn and the Department of Energy and Environmental Protection to get their agency vehicles titled. Once they are completed, DAS Surplus Staff will be reaching out to other state to assist in getting their vehicles titled, as well.



We've Added a few NEW features to our DAS Webpage
