Notice to Appointing Authorities

Change in application process:

Proof of meeting one of the minimum standards of qualifications identified in CGS 29-298(a) must be included with application. This can be a letter from the candidate's employer or department on letterhead. See back page for details.

Every effort will be made to hold live training classes. If the COVID-19 pandemic dictates, OEMD will provide online instruction in place of in-person classes.

Requirements to Apply for Either Module

- ✓ Candidate must be at least 18 years of age
- ✓ Candidate must have a high school diploma or equivalent.
- ✓ All candidates, regardless if sponsored by an Appointing Authority or not, must provide a letter from their employer or department documenting that they meet **one** of the minimum standards of qualifications as set forth in CGS Section 29-298(a). See back page.
- ✓ Appointing Authority (if applicable) must provide signed statement indicating that s/he will appoint the applicant once the applicant has earned certification.

Requirements to Become Certified as a Fire Marshal

- ✓ Candidate must be certified as a Fire Code Inspector
- ✓ Candidate must be certified as a Fire Investigator
- ✓ All candidates, regardless if sponsored by an Appointing Authority or not, must have provided a letter from their employer or department documenting that they meet **one** of the minimum standards of qualifications as set forth in CGS Section 29-298(a). See back page.

The applicant must submit a letter from his/her employer documenting years of qualifying employment (see back page). **Without the letter the application will not be processed.** Only one letter per applicant required.

- At least three years experience in inspection activities concerning the fire safety or prevention code or hazardous materials
- At least three years experience in the investigation of the cause and origin of fires and explosions
- At least three years experience as a member of the Connecticut State Police or local police dept. _____
- Equivalent experience as determined by the State Fire Marshal and the Codes and Standards Committee
