a. A-6-16. Request for appeal from 89 Prospect Street, LLC c/o John Forrest re: State Fire Marshal's decision re: 26.3.5.1 re: 44-46 Connecticut Boulevard, East Hartford, CT. On 5/31/16 referred to Office of State Fire Marshal (OSFM) for review. OSFM contacted the local fire marshal and was waiting for receipt of a modification; however, when the 2016 Fire Safety Code was adopted, the building became code compliant. OSFM will contact the appellant and request a withdrawal of this appeal.
