Proposed <u>S.B. No. 587</u> SEN. FLEXER, 29th DIST. 'AN ACT CONCERNING RESTITUTION FROM PERPETRATORS', to require full restitution from perpetrators regardless of changes to their parole or probation status. REF. JUDICIARY
