<u>SB-148</u>	AN ACT CONCERNING PASSENGER RESTRICTIONS ON HOLDERS OF MOTOR VEHICLE OPERATOR'S LICENSES WHO ARE SIXTEEN OR SEVENTEEN YEARS OF AGE.
<u>SB-157</u>	AN ACT PERMITTING THE USE OF THE ARBITRATION PROCESS TO RESOLVE CHILD CUSTODY, VISITATION AND SUPPORT ISSUES IN A DIVORCE PROCEEDING.
SB-158	AN ACT ESTABLISHING THE COVID-19 EMERGENCY EVICTION AND FORECLOSURE PREVENTION ACT.
