ACCOMPLISHMENTS - CANDIDACY

- Tasked with defining Connecticut's Family First Candidacy Population
- Selected the following:
 - Accepted Careline calls- allegation of abuse or neglect or Voluntary Services referral
 - Youth who achieve any kind of permanency (adoption, reunification, etc.) and youth who age out
 - Pregnant and parenting youth in foster care
 - Siblings of children/youth in foster care
 - Community pathways (unstably housed, JJ involved, infants born substance exposed, families with a caregiver or child that has disability, MH or substance use issues, youth who are trafficked, families experiencing IPV, children of incarnated parents, or children chronically absent or truant)

CANDIDACY - NEXT STEPS

- Shift focus to infrastructure development Rebrand
 - Prevention Infrastructure & Practices
- Enhance workgroup to include key informants/stakeholders and persons with lived experience
- Explore community partnership opportunities for system design
- Identify IT modifications needed to support family engagement
- Review screening tools and mechanisms to best support families
- Determine the workforce responsible for administering the tools
- Align practice and policy to accompany the enhanced pathways to services
- Engage focus groups to seek consumer feedback at critical junctures of system design
- Seek Governance Committee approval

ACCOMPLISHMENTS - KINSHIP AND FOSTER CARE

- Identified and assessed barriers to children living with relatives or kin both in informal family arrangements or formal and legal arrangements
- Recommended ways to address and mitigate the identified barriers and support relatives and kin better so that they can meet ongoingly the needs of children who live with them
- Identified strategies to engage relatives and kin at the onset of the potential disruption in a birth parent or caregiver relationship and continue engagement for as long as the agency is involved with the family
- Identified strategies to increase children's placement with well-prepared kin and family-based caregivers when foster care is necessary as a primary way to avoid congregate care
- Identified key components of a Kinship Navigator program that can help facilitate relatives getting care for children outside of formal systems of care

KINSHIP AND FOSTER CARE – NEXT STEPS

- Develop a Connecticut model of Kinship Navigation which may qualify for federal entitlement funding under the Family First Prevention Services Act (Family First). Such a model must contain components for Kinship Navigation prescribed in federal law and demonstrate that it is an evidence-based practice
- Moreover, such a model must be aligned with DCF's practice model for working with kin families to have the intended impact of supporting children in healthy families with a minimal amount of child welfare system involvement

ACCOMPLISHMENTS - PROGRAMS AND SERVICE ARRAY

- Mapped CT's continuum of services that strengthen families across multiple domains and where located:
 - Primary interventions
 - Targeted interventions that support families
 - Interventions offered during placement
 - Aftercare interventions/supports
 - Other interventions
- Identified where services currently offered in CT align across domains and which had Family First Clearinghouse approval
- Identified where gaps existed and other possible interventions to explore
- Reviewed approved candidacy definitions and aligned identified services by candidacy group
- Began to assess evidence base for each to determine which programs/services were already approved or likely to be approved based on level of research/evidence base

PROGRAMS AND SERVICE ARRAY – NEXT STEPS

- Review revised CT Family First submission timeline
- Review progress through March to refresh members on what's completed
- Based on candidacy definitions remaining current, review the service alignment mapping by candidacy group
- Orientation session for new members
- Discuss outstanding questions around services where model's evidence base may require more research
- Finalize recommendations for candidacy plan to submit to Governance by December 2020
- Retain mapping to guide development of prevention plan

ACCOMPLISHMENTS - INTENSIVE TREATMENT 24/7 (QRTP)

- Completed a survey of residential and therapeutic group home providers on the QRTP requirements and cross walked that with scopes of service; honored the vision of QRTP as efficient treatment settings that provide pathways to living in homes
- Surveyed providers on accreditation status and collected information on trauma models
- Set up four taskforces
- Drafted a certification process for review
- Worked diligently with ACF on questions and pulled examples of processes from other jurisdictions, and will continue to do so as needed

INTENSIVE TREATMENT 24/7(QRTP) – NEXT STEPS

- Embed QRTP language in state statute
- Develop recommendations from the four taskforces: certification, aftercare, family engagement/treatment and workforce development opportunities, judicial review
- Build upon lessons learned during COVID that may help in the future

FISCAL AND REVENUE ENHANCEMENT

Accomplishments:

• Receipt of the Maintenance of Effort report; the Department is analyzing it against CTs fiscal information for the baseline year of 2014

Goals Moving Forward:


