	3. Child Fatalities (volunteer lead: Faith Vos Winkel) There was a proposal for funding and support to develop a community level child fatality review process that was distributed at the meeting. Many other states have a community based child fatality review entities. There was a Commission that was established on a federal level to eliminate child abuse and neglect fatalities. There was an issue around what was reported as a child maltreatment fatality. The proposal is to fund a part time position for 7 years to look at data. The position would be funded at \$25,000 annually. The objectives and deliverables were presented at the meeting. MDT/CACs would get a timely notification of infant death along with resources that are not normally available(child welfare, educational, medical records could be accessed) Is there a consideration to racial, ethnic and socio – economic disparities? MDT- What is the role beyond seeing cases at the table? Education in the community, Education of team members. MA is the only state that has this review at the local level. Philadelphia has 12 Fatality Review Panels.	possible funding sources. Krystal to send out information from other states on how this is addressed.
