

SHIFTS IN BEHAVIOR

Empowering youth – the My Life My Choice Curriculum

A National Institute of Justice-funded three-year evaluation of the My Life My Choice Exploitation Prevention Curriculum found the following:

- Knowledge about CSEC and risks for exploitation improved for all participants, particularly for those who were 11-15 years old and those in a residential facility.
- Experiences of commercial sexual exploitation decreased by 50% immediately after group.
- Participants were 2 times less likely to report dating abuse victimization in the past three months at the six-month follow-up.
- 100% of youth provided CSEC-related help to a friend or other people in the past three months after participating in the prevention group.
- Self-reported sexually explicit behaviors were reduced by half over time.


