ACTION TAKEN: On Wednesday May 17th, 2017, multiple members of Western District Major Crime (WDMC) conducted comprehensive neighborhood canvasses of Magnolia Street in Bridgeport, Iranistan Avenue in Bridgeport, and of their respective surrounding areas. These canvasses were an attempt to gather any information related to this investigation from any residential witnesses and/or surveillance

The canvass of Iranistan Avenue, Benham Avenue, Maplewood Avenue commenced at approximately 1100 hours and ended at approximately 1215 hours. During said canvass, multiple residences were contacted, however, no information related to this investigation was obtained.
