NEIGHBORHOOD CANVASS

ACTION TAKEN:

On June 22, 2017, between approximately 1400 hours and 1430 hours, Det. Grabowski and I conducted a neighborhood canvass on Magnolia Street, Bridgeport regarding events that led up to the officer involved shooting incident on May 09, 2017. During the canvass, I approached the following addresses:

Magnolia Street - I spoke with an [redacted] who only identified herself as the caretaker for the small children who resides at the residence. The female related she was from [redacted], and stays with the family Monday through Friday, returning to [redacted] on the weekends. The female did not wish to be identified, stating several times she didn't know anyone from Bridgeport. This residence did not appear to have any exterior video cameras.

Magnolia Street - I spoke with [redacted], date of birth; [redacted], who related she does not involve herself in what goes on outside of her residence. [redacted] was shown photos of both Negron and [redacted] relating she did not recognize either one. The residence did not appear to have any exterior video cameras.

Magnolia Street - There was no contact made at this address and did not appear to have exterior video cameras.

Magnolia Street - I spoke with _____, date of birth; _____, who related she was aware of the police involved shooting but did not realize it was her neighbor until there was police presence after the incident. _____ did not recognize Negrón or _____ even after she was shown a photo. The residence did not appear to have any exterior video cameras.

Magnolia Street - I spoke with _____, date of birth; _____ who related he did not know either Negrón or _____ even after he was shown a picture of both. _____ related shortly after the shooting incident Negrón's father had been to his residence asking if he had any video footage. _____ related he did not provide the man who claimed to be Negrón's father with anything. _____ related for the most part the family kept to themselves. _____ related his house is equipped with video cameras covering all angles of the residence but are only activated through a motion sensor and any stored data would be in small increments. _____ was asked if the hard drive had the capability of retrieving video footage prior to May 9, 2017. _____ in my presence attempted to retrieve video footage only to find that the hard drive would freeze, not allowing him to access anything. _____ related he would need to upgrade the hard drive in order to retrieve anything that was more than a week old. The front door camera was pointed in a south/western direction providing a small unobstructed portion of Magnolia Road. _____ was provided my contact information and was asked to contact me if he was able to retrieve any video footage prior to May 9, 2017.
