Neighborhood Canvass

**Action Taken:** On 05/17/17, Det. J. Pearston #475 and I were assigned to conduct a follow-up neighborhood canvass in connection to an officer involved shooting, in the areas of Park Ave., John St., Fairfield Ave., and West Ave. in Bridgeport, CT.

At approximately 1050 hours, we spoke with \_\_\_\_\_, a \_\_\_\_\_, located at \_\_\_\_\_ Park Ave., Bridgeport, CT. He stated the restaurant did not have any interior or exterior security cameras.

At approximately 1055 hours, we spoke with \_\_\_\_\_, which operates out of the \_\_\_\_\_ building located at \_\_\_\_\_ John St., Bridgeport, CT. There were visible exterior security cameras, however, none of them pointed in the direction towards the area in question, and, furthermore, they were motion activated cameras that only turn on when motion is detected. \_\_\_\_\_ stated he was at work at the time the incident took place but did not hear or see anything; he only became aware of the incident when he left work and saw the police activity.

At approximately 1110 hours, we went to \_\_\_\_\_ Fairfield Ave., Bridgeport, CT. A female answered the door and stated she saw nothing pertaining to the incident in question. She also stated she did not want to provide identification.

None of those cameras pointed in the direction of the incident. Det. Pearston and I viewed this on the computer monitor for the security videos as well.

between 1700 and 1715 hours, and nothing was seen from that camera that pertained to the incident.

At approximately 1145 hours, we went to \_\_\_\_\_ Fairfield Ave., Bridgeport, CT. There were no visible exterior security cameras and no contact was made.

At approximately 1150 hours, we went to \_\_\_\_\_ West Ave., Bridgeport, CT, a construction site where new housing is being built. The site did not have any security cameras. The superintendent of the project, \_\_\_\_\_, stated he received two videos and two photographs from another worker on his business cell phone. He stated the videos and images were taken from this worker's drone, which he put up in the air immediately following the incident. He stated this worker told him he took the drone down for fear of having it confiscated. \_\_\_\_\_ played both videos and showed us both images, and, upon request, forwarded them to Det. D. Pandiscia's department issued iPhone. \_\_\_\_\_ was asked not to delete those files and to relay that same request to the worker who took the original footage. I gave \_\_\_\_\_ Det. Kimball's contact information. \_\_\_\_\_ signed a Consent to Search and Examine Evidence form in relation to us viewing and sending those files.

She also stated the building has no exterior cameras. She also stated there are no cameras at the church
