I, Kevin Handel, date of birth '88

make the following statement, without fear, threat, or promise. I have been advised that any statement(s) made herein which I do not believe to be true, and which statement is intended to mislead a public servant in the performance of his/her official function, is a crime under C.G.S. section 53a-157.

I Kevin Handel am a 28 y/o AEMT working for AMR Bridgeport for 6 years. I have <sup>traveled (KA)</sup> seen multiple calls involving shootings and am well experienced in on scene care. On this day of 05/04/17 I was working an ALS <sup>Advanced Life Support</sup> truck meaning I was on board with a higher-level of Care paramedic. At the time ~~of~~ dispatch we were posted in the town of Fairfield. Once dispatched to call I was the driver and went on high priority <sup>with lights and sirens (KA)</sup> using the fastest route to the scene. When <sup>Andrew and I (KA)</sup> arrived on scene, supervisor <sup>Calzone (KA)</sup> 709<sup>A</sup> was already beginning the triage. I got out grabbed the stretcher and all gear and was pointed to the patient. My partner and I were to begin care on. Supervisor had triaged prior to our arrival and guided to our patient. I focused on the patient I was told to focus on by a higher level of care triage system. After patient was properly treated, patient was placed on stretcher supine with sheet. I assisted my paramedic partner in the back of the ambulance with care, IV bags, monitor leads, ~~etc.~~  
I then moved to the drivers seat and transported patient to Bpt Hospital with lights and sirens using the shortest, fastest route.
