consented to a search of his 2005 Pontiac Montana SV-6 bearing Connecticut registration and provided the following written statement:

. I was driving my 2005 Pontiac mini van bearing Connecticut registration . I just dropped off my friend on Noble Ave. and was the only one in my vehicle. I was traveling up Fairfield Ave. at around 5 PM. Prior to me coming to the intersection of Park Ave. and Fairfield Ave. I saw a small gray Subaru come out of the Walgreens parking lot and cut in front of me. Fairfield Ave. is a one way street and this car wanted to go the wrong way and try to pass me, but there was no room. The Subaru couldn't go down and the vehicle tried backing up, but the police car (color black and white) was right behind the Subaru. The police car had its emergency light on. I saw the police car stop and saw a police officer (in uniform) running from the parking area of Walgreens. I heard the police officer yell," Stop", but the Subaru wouldn't stop. The Subaru kept backing up at a fast rate trying to leave quickly. I don't know where the other police officers came from, but they were there quickly. There were police officers trying to open the driver's door and passenger's door to get them out. couldn't see inside the Subaru or what the guys were doing, but they were not opening the doors. Once the police officer got the driver's door open, I heard gun shots. I don't know where they came from or who shot. I then saw another police officer open the passenger's side door and place a black young male on the ground and place handcuffs on him. I then saw an ambulance arrive and cut the shirt on the passenger and rendering aid. They put something on this back and took him away by ambulance. Once the driver's door was open, I couldn't see the driver or see what happened. I was then instructed by the police to stay inside my vehicle. Later on, a police officer took my information and I left the scene. During this incident, my windows were fully up and were rolled down when I spoke to the police. I don't remember how many shots I heard, maybe 3 or 4 shots.

I wanted to add that when I was first driving down Fairfield Ave., there was a vehicle along side of me. I don't remember what kind it was or when it left. Also, when the Subaru came out of Walgreens, it struck my vehicle on my passenger's side, mirror and side. I am not hurt." (See attached 2-page statement and consent form).
