the 5 Star Pizza Restaurant. At approximately 4:30 PM, he observed the suspect vehicle which he could only describe as a blue/ gray colored car, turn onto Fairfield Avenue from Park Avenue. The suspect vehicle was being chased by Bridgeport Police vehicles. The suspect vehicle appeared to have been stopped by the oncoming traffic. He observed Bridgeport Police Officers approach the suspect vehicle with their weapons drawn and he heard a lot of yelling and screaming. He could hear the police officers yelling to stop and get out of the vehicle numerous times. He heard approximately 5 gun shots which he described as 2 gun shots followed by 3 gun shots. He never observed who was shooting nor did he see who was driving the suspect vehicle because his view was obstructed. After he heard the gun shots, he and his wife took into the restaurant. Approximately 15 minutes later, he went outside the restaurant and observed ambulances on scene and a police officer being taken away on a stretcher. He went back into the restaurant to finish his meal and approximately 45 minutes later, he and his family left the restaurant and drove to the Bridgeport Police Department to report what he observed.

I transcribed the information related into a written statement consisting of two (2) pages. reviewed the written statement for clarity and content.
