



- *01:59:13-Maldonado led into the cell by Officers Kaplan and Cohen.*
- *02:00:52-Maldonado removes shirt.*
- *02:01:28-Ramos led into processing area by officers. Maldonado appears to engage conversation.*
- *02:02:26-Maldonado begins to unbutton pants.*
- *02:04:03-Maldonado appears to speak to Ramos and officers through the cell.*
- *02:04:26-Maldonado begins to remove his pants.*
- *02:04:36-Officer opens cell door.*
- *02:04:37-Maldonado moves toward door and officer attempts to close it.*
- *02:04:38-Maldonado opens the cell door and advances toward officers.*
- *02:04:42-Maldonado and Ramos pushed back into cell by officers.*
- *02:04:43-Maldonado and Sgt Lis hit/punch at each other.*
- *02:04:46-Sgt Lis backs away as Officer Kaplan approaches and tasers Maldonado.*
- *02:04:48-Sgt Lis punches Maldonado, knocking him to the floor.*

- 02:20:08-AED shock pads positioned on Maldonado, evaluation being conducted, shock doesn't appear to be administered.
- 02:20:12-EMT resumes CPR.
- 02:29:43-EMT's remove Maldonado for transport
