The Commission reviewed June 13, 2013 request from Angelini Wine Ltd. requesting to deliver alcoholic liquor products ordered on or before July 31, 2013 through August 2, 2013. The Commission denies the request at this time since the wholesaler did not indicate a specific reason for the request other than the month ends and a new month begins during the same business week. The Commission noted that there may be times when the department allows a wholesaler or wholesalers to extend deliveries into the following month when supplier deliveries are interrupted due to circumstances beyond the control of the wholesaler. The Commission noted that this is allowed on an individual basis upon a written petition to the department and requires clear and convincing proof that the inability of the wholesaler to the deliver the affected product in the month it was ordered was beyond the control of the wholesaler.

37. ANHEUSER-BUSCH – LSB.832

Saint Louis, MO

The Commission reviewed June 24, 2013 correspondence from Associate General Counsel Lisa Graivier Barnes of Anheuser-Busch (AB) concerning a quality control issue involving its glassware brought to the department's attention relating to the Busch brand-12 ounce non-returnable bottle package of 20 longneck bottles. The department also heard from Attorney Robert Shea of the Connecticut Beverage Coalition and Director Suchy. As a result of the review of the matter, the department grants the following as it relates to the affected product, namely the 12-ounce nonreturnable bottle packages of 20 longneck bottles, the following extensions: (1) the pricing AB posted to wholesalers as of June 23, 2013 is extended through July 6, 2013, (2) the pricing posted by the CT wholesalers based upon the AB pricing as of June 23, 2013 such beer at the pricing posted by such wholesalers based upon the AB pricing as of June 23, 2013.
