Legal Matters

Case No. 2020-947 Phong T. Nguyen

Attorney Michael Ando presented this case. Commissioner Cafferelli 'stepped down'. Summary: The Licensee is a pharmacist that has been investigated by the Drug Control Division for allegedly failing to maintain inventory for controlled substances, combining returned/misbranded prescriptions with open stock bottles and failing to produce records upon an agents request. The Licensee Pharmacist had a prior agreement with the Commission of Pharmacy in an unrelated case to step down as pharmacy manager and not serve as a pharmacy manager again without coming before the Commission; Licensee did not notify the Commission prior to obtaining a position as pharmacy manager in accordance with the prior agreement.

<u>Proposed Resolution:</u> This proposed Settlement Agreement calls for the Licensee Pharmacist to pay a \$1,500.00 civil penalty, and to step down as pharmacy manager and not be employed or otherwise serve as a pharmacy manager and/or perform the duties of a pharmacy manager indefinitely; to promptly inform his employer of the Settlement Agreement, and to complete a continuing education course on quality assurance. All agreed upon terms have been fulfilled.

Commission Action: Commissioner Inguanti moved, seconded by Commissioner DeFazio and passed by a vote of 6-0 to accept and approve the aforementioned settlement agreement.

'First Time' Pharmacy Manager(s)

Commissioner DeFazio provided a summary of the responsibilities that a first-time pharmacy manager has and appreciated their appearance before the Commission. Pharmacist Renewal 2022 Continuing Education

The CE credits that she obtained in 2022 and applied to the 2020 and 2021 renewal cycle to be compliant can not be used going forward for the upcoming renewal on January 31, 2024.

Miscellaneous Matters

Pharmacist / Pharmacy Technician Ratio – Regulation 20-576-33

General Declarations of Public Health and Civil Preparedness Emergencies passed by General Assembly is due to expire on June 30, 2022

A waiver in reference to operations of pharmacy law (regulation 20-576-59) of Tech Ratio 3-1 to be able to increase Tech Ratio 4-1 in preparedness of COVID 19 Epidemic. Commissioner DeFazio moved, to extend the 4-1 Tech-Ratio 90 days, until October 1, 2022, seconded by Commissioner Caffarelli.

Discussion: In further review of pharmacy operations, COVID 19 uncertainties and to give pharmacies time to prepare to return to a 3-1 Tech Ratio. it was determined to amend the motion of 90 days and extend the date until the end of the year.

Commission Action:

Commissioner DeFazio moved, seconded by Commissioner Cafferelli and passed by a vote of 6-0 to extend pharmacy operations of Technician Ratio 4-1 until December 31, 2022, upon the expiration date the Technician Ratio will return to Technician Ratio of 3-1.

Request to Increase Phamacy Tehnician Ratio

Community Pharmacy – Norwalk Allison Wiencek, Pharmacy Manager

The pharmacy provides Long-term Care Services and is requesting a waiver to keep the Technician Ratio 4-1. Ms. Wiencek stated that having a fourth Pharmacy Technician helps in pharmacy operations and processing prescriptions safely for patients.

Commission Action:

Commissioner DeFazio moved, no seconded motion, the request is not accepted. The matter will be tabled, as the 4-1 Technician Ratio has been extended until December 31, 2022.

Pharmacist License Renewal Change / Annually

Gina Samples, clarified a change notice affecting general statue 20-593,

Effective July 1, 2022, the Pharmacist license renewal has changed to an annual renewal and, renewal fee of \$100.

Pharmacists that obtained license after the July 1, 2022, the license renewal date will have an expiration date of January 31, 2023.

Pharmacists that renewed the license <u>before</u> July 1, 2022, the license expiration date will remain as January 31, 2024.
