Legal Matters

Docket Number 2018-2510 Ryan Christopher Bango Attorney Lila McKinley presented this case. Commissioner Carbray 'stepped down'. This case involved The Licensee is a pharmacist that has been investigated by the Drug Control Division for allegedly performing incompetent or negligent work. This proposed Settlement Agreement calls for a \$1,000.00 civil penalty, completion of an online continuing education course, and a letter of reprimand.

Commission Action: Commissioner Inguanti moved, seconded by Commissioner Chisholm and passed by a vote of 3-0 to accept and approve the aforementioned settlement agreement.

Docket Number 2018-3855 Steven Dixon

Attorney Lila McKinley presented this case. Commissioner DeFazio 'stepped down'. This case involved The Licensee is a pharmacist that entered into a 5 year monitoring agreement to reinstate their pharmacist license and was accepted and approved by this commission at its November 15, 2017, meeting (see case 2016-1253). The licensee self-reported a relapse on January 3, 2019. Drug Control Agents met with Licensee and submitted proposed additions and actions. The proposed Agreement includes a new 5 year monitoring from the date of acceptance, adds an additional screening and reporting requirements (bi-monthly screens and monthly reports from the treating therapist) and suspends the pharmacist's license from the date of the relapse (December 27, 2018) for thirty (30) days.

Commission Action: Commissioner Inguanti moved, seconded by Commissioner Chisholm and passed by a vote of 3-0 to accept and approve the aforementioned settlement agreement.

Miscellaneous Legal Matters

Attorney Lila McKinley discussed Jeff Ryan to modify the agreement to exclude the requirement that meetings be with a pharmacy recovery group.

Commission Action: Commissioner Inguanti moved, seconded by Commissioner Chisholm and passed by a vote of 4-0 to accept and approve the modification of the aforementioned settlement agreement.

'First Time' Pharmacy Manager(s)

Commissioner DeFazio provided a summary of the responsibilities that a first-time pharmacy manager has and appreciated their appearance before the Commission. Commissioner DeFazio emphasized the importance of the pharmacy manager's role in contrast to the front-store manager (in many retail settings). Some responsibilities include leadership, technician registration, license renewals, and prescription error reporting.
