Legal Matters

Docket Number 2018-42 Jignashu Parikh

Attorney Bryan Cafferelli presented this case. Commissioner Carbray 'stepped down'. This case involved The Licensee is a pharmacist that has been investigated by the Drug Control Division for allegedly performing incompetent or negligent work, in violation of Section 20-579(a)(15) of the Connecticut General Statutes by dispensing the wrong medication to a patient.

Proposed Resolution: This Settlement Agreement calls for the licensee to pay a \$1,000.00 civil penalty, receive a Letter of Reprimand and completion of an additional five (5) hours of continuing education per year, for three (3) years from the date of the Settlement Agreement. The hours are in addition to the annual continuing education requirements for pharmacists and must be related to prevention and/or root cause analysis of prescription errors.

Commission Action: Commissioner Goodmaster moved, seconded by Commissioner Chisolm and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.

Attorney Bryan Cafferelli presented this case. Commissioner Chisolm 'stepped down'. This case involved The Licensee is a pharmacist that has been investigated by the Drug Control Division for violating an order of the Commission of Pharmacy, in violation of Section 20-579(a)(1), (3) and 21a-7(7) of the Connecticut General Statutes. **Proposed Resolution:** This Settlement Agreement calls for the licensee to pay a \$1,000.00 civil penalty, receive a Letter of Reprimand and completion of an additional five (5) hours of continuing education per year, for three (3) years from the date of the Settlement Agreement. The hours are in addition to the annual continuing education requirements for pharmacists.

Commission Action: Commissioner Inguanti moved, seconded by Commissioner Goodmaster and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.

'First Time' Pharmacy Manager(s)

Commissioner DeFazio provided a summary of the responsibilities that a first-time pharmacy manager has and appreciated their appearance before the Commission. Commissioner DeFazio emphasized the importance of the pharmacy manager's role in contrast to the front-store manager (in many retail settings). Some responsibilities include leadership, technician registration, license renewals, and prescription error reporting.
