Case Number 2019-745

Attorney Michael Ando presented this case. Commissioner Cafferelli 'stepped down'. This case involved Following a suspicious order investigation, deficiencies were found in perpetual inventory, records, and orderly maintenance of the pharmacy premises. Additionally, the pharmacy operated for a period without a designated pharmacy manager.

Proposed Resolution: In consideration of a number of voluntary steps taken by the pharmacy, staff of the pharmacy, and management to improve operating procedures and ensure no future problems of this nature, and with documentation of staffing changes made, this agreement calls for voluntary settlement payment in the amount of \$2,000.

Commission Action: Commissioner Carbray moved, seconded by Commissioner Chisolm and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.

'First Time' Pharmacy Manager(s)

Commissioner DeFazio provided a summary of the responsibilities that a first-time pharmacy manager has and appreciated their appearance before the Commission. Commissioner DeFazio emphasized the importance of the pharmacy manager's role in contrast to the front-store manager (in many retail settings). Some responsibilities include leadership, technician registration, license renewals, and prescription error reporting.
