Legal Matters

Case Number 2019-1265

Attorney Michael Ando presented this case. Commissioner Carbray 'stepped down'. This case involved the former pharmacy technician licensee seeks approval for a pharmacy intern license. In 2010, the former pharmacy technician voluntarily surrendered their license following an arrest involving drugs, which did not occur at the pharmacy where the former technician was employed. Following this incident, the former technician engaged in counseling, and therapy, and maintains treatment and counseling. The former technician has been accepted into a Doctor of Pharmacy program. A step-down meeting occurred in September of 2019 with Commissioner Carbray.

Proposed Resolution: Counsel for the Drug Control Division proposes an equivalent agreement to a reinstatement agreement that would bind a pharmacist seeking reinstatement following a similar event. This agreement would call allow the individual to be licensed as a pharmacy intern, but would subject them to a five year probation period including documented substance abuse treatment at prescribed intervals, self-help group treatment, urine and/or blood screens at prescribed intervals, abstinence from substances, and reporting to the Drug Control Division for monitoring purposes.

Commission Action: Commissioner Inguanti moved, seconded by Commissioner Chisolm and passed by a vote of 4-0 to accept and approve the aforementioned settlement agreement.
