Legal Matters

Case Number 2021-30 Shri Tiwari

Attorney Michael Ando presented this case. No Commissioner 'stepped down'. This case involved Respondent is a Connecticut Pharmacist, acting as a Pharmacy Manager, who was investigated following a report of controlled substance losses. During the course of investigation, deficiencies were found in record keeping of controlled substance prescriptions, maintenance of dispensing records, maintenance of controlled substances in a secure area or location, adequate locking of controlled substances, timely reporting of losses, and failure to store controlled substances in an approved safe, cabinet, or dispersed throughout stock within the compounding area.

Proposed Resolution: Counsel for the Drug Control Division proposes an agreement in which Respondent shall be placed on a probationary status for a period of three months from the effective date of this agreement. During this period, Respondent shall maintain all security measures ordered or implemented during the investigation and shall not serve as a pharmacy manager. Respondent shall take the CE Manager Course. The agreement also calls for a voluntary settlement payment in the amount of \$1,500.

Commission Action: Commissioner Cafferelli moved, seconded by Commissioner Inguanti and passed by a vote of 4-0 to accept and approve the aforementioned settlement agreement.

Case Number 2021-74 Mathew Chaber

Attorney Michael Ando presented this case. No Commissioner 'stepped down'. This case involved Respondent is a Connecticut Pharmacist who was investigated following a report of controlled substance losses. Respondent was investigated for failure to insure adequate security of the prescription department.

Proposed Resolution: Counsel for the Drug Control Division proposes an agreement in which Respondent shall maintain security measures ordered or implemented during the investigation and shall not serve as a pharmacy manager for three months along with a three-month probation. Respondent shall take the CE Manager Course and pay a voluntary settlement in the amount of \$1,000.

Commission Action: Commissioner DeFazio moved, seconded by Commissioner Inguanti and passed by a vote of 4-0 to accept and approve the aforementioned settlement agreement.

'First Time' Pharmacy Manager(s)

Commissioner DeFazio provided a summary of the responsibilities that a first-time pharmacy manager has and appreciated their appearance before the Commission. Commissioner DeFazio emphasized the importance of the pharmacy manager's role in contrast to the front-store manager (in many retail settings). Some responsibilities include leadership, technician registration, license renewals, and prescription error reporting.

- 2) Review our current CT pool of test questions (these are previously selected pretest and scored items/questions)

The review and selection assignment was completed and submitted on the due date of September 17, 2021.
