Legal Matters

Case Number 2019-1430

Attorney Michael Ando presented this case. Commissioner Linder 'stepped down'. This case involved Summary: During a routine inspection, an agent discovered an individual allegedly working as a pharmacy intern, however this individual did not have a pharmacy intern license. The individual was remorseful, cooperative with the agent and expressed a lack of understanding, indicating they believed that they were considered a pharmacy intern as they were waiting for their employer to file licensure paperwork with the Drug Control Division. Immediately following the inspection, the individual requested and was granted a pharmacy technician registration, and submitted paperwork for a pharmacy intern license. A step-down meeting occurred in October of 2018 with Commissioner Linder.

Proposed Resolution: Counsel for the Drug Control Division proposes an agreement in which the individual would withdraw the pending pharmacy intern application and wait for a period of no less than three months before reapplying. After three months, at re-application, the Drug Control Division would offer no objection to an application for a pharmacy intern license.

Commission Action: Commissioner Carbray moved, seconded by Commissioner DeFazio and passed by a vote of 3-0 to accept and approve the aforementioned settlement agreement

'First Time' Pharmacy Manager(s)

Commissioner DeFazio provided a summary of the responsibilities that a first-time pharmacy manager has and appreciated their appearance before the Commission. Commissioner DeFazio emphasized the importance of the pharmacy manager's role in contrast to the front-store manager (in many retail settings). Some responsibilities include leadership, technician registration, license renewals, and prescription error reporting.
